Object. Unless more parking for residents is provided. Or rules relaxed on creating off street parking. Maybe allow cars to park in the car park on St Martins Road for more than 24 hours, Like it used to be. Parking is becoming a major problem in Wroxall. I do think that with less cars parked on the road it encourages drivers to go faster. The cars parked on the road force the cars to slow down. If double yellows are introduced then some provision needs to be made for residents that loose those spaces.

It may ease traffic flow but it will then increase the speed of the traffic causing more potential for accidents to both motorists and pedestrians especially children. Just prior to the proposed yellow lines between Rowena and Hazel Dene is a length of street which does not have a pavement on one side. This stretch of road is also used by cyclists on the Red Squirrel trail as well as those coming off the cycle track by way of the steps just north of the proposal for yellow lines outside Normanton. In addition many homes in these areas do not have parking so rely on street parking. The current parking slows up the flow of traffic making it safer for all so please do not add yellow lines to this area.

Hello, I would like to object to the proposal to create a no parking zone along St Johns Road, Wroxall. I believe this is to make the road safer for pedestrians and road users. As a resident of this road, I can confirm that the current parking of vehicles on this road, provides a natural curb on motorists speed. This enables a safe place for pedestrians to cross the road

and also slows the traffic to enable a safe exit from

Appuldurcombe road onto St Johns road. If you remove the parking on St Johns road, it is inevitable that traffic will speed beyond the 30mph limit thus creating significant danger to pedestrians and cyclists. By removing the parking for the residents along this road will create further danger to the surrounding roads (Coombe Park) as this would be the nearest road to park our car. I wonder if there has been any consideration to the residents affected by the proposal and it's impact on our daily life's?

We write to offer our strongest objections to the proposition of removing parking from St John's Road and other areas of Wroxall. We have long experienced how dangerous this road is as traffic begins it's acceleration from The Worsley before realising there is little room or time to avoid any traffic appearing over the rise.

we have witnessed vehicles on their side, there are several dozen examples of side mirrors being torn off, residents front garden walls being demolished, a continuous sound of car horns denoting near-misses and we have narrowly avoided being hit by drivers barely in control as we enter or exit our vehicles.

If you take parking away you will allow traffic to tear through Wroxall without obstacle. There will be increased damage to property or worse.

Wroxall is desperate for extra parking, not less, and the construction of new parking bays can be used as natural chicanes to slow traffic, solving two problems simultaneously. The very concept of losing swathes of parking through Wroxall is a dangerous insanity and we will strongly oppose this proposition.
