I am emailing from strengthening families on behalf of one of the families I support. I am after some information on transport options for a young boy with SEN. The situation is that he is due to start school in September and is currently finalising his EHCP. He has requested to go to Medina House school but has been told there are no places this year so they have offered him a place at their nursery. The family are concerned they will not be able to get him there and back as they have other children in two different schools so have asked if I can explore if there is any funded transport options. I realise this is not usual to provide transport to a nursery but I wondered if it would be different as this child is of school age but cannot start this year as there are no suitable places for him. I called transport and they said you contact you.

Good afternoon,

We are 2 qualified primary school teachers who have set up a tutoring business in Arreton on the Isle of Wight. We offer bespoke learning for each child covering the core subjects of Maths, English, Reading and Phonics as well as outdoor learning, cookery and beach school.
