Good Morning

I wonder if I can take a few moments of your time to bring to your attention the lack of occupational therapists on the Isle Of Wight for children. My son was diagnosed with high functioning Autism last September. He is currently being assessed for an EHCP . An OT assessment would provide clarity into the daily challenges faced within the school environment. I've spoken to Adult Island OT s and it would appear there are no OT s available for child assessments ? I'll have to pay a private mainland OT anything from £ 200 for a sensory integration assessment and /or up to £700 for a full assessment. I feel this in a huge gap in the provision on the Isle Of Wight. Who can I bring this to the attention of ?

Secondly for sometime I have used the Short Breaks to facilitate activities for my son during the Summer holiday, due to his Autism he generally doesn't like group activities hence tree climbing and UKSA have worked well . Unfortunately UKSA have withdrawn their provision. I contacted them direct and they offer a week long block for £255 !! Isle Of Wight Adventure now offers 2.5 hours for £25 which is quite expensive. I have spoken to Little Canada who offer 2 activities and lunch for £16 which is good value for money and all the activities are in one place. This PGL centre based in Wootton is also very well staffed. I genuinely think this is a great opportunity that the Isle Of Wight Council could tap into. I am unable to book it as an individual for my son as there is a minimum group booking of 12. They already work with the Phoenix Project which supports adults with learning disabilities / Autism.

Thank you for your feedback. The Local Offer is continually developing and your views are important with helping the Isle of Wight Council to shape future services as well as the Local Offer website. We are sorry to hear that the service offered on the island around Occupational Therapy (OT) and sensory integration have not met your expectations.

The IW NHS Trust Occupational Therapy service delivers holistic assessments for children as part of the Education Health Care Plan (EHCP) who have a physical disability or significant physical impairment as well as those with a diagnosis of ASD. In terms of ASD the OT service delivers intervention to meet needs identified on the health section of the EHCP and not needs identified on the education section. For children with a physical disability or significant physical impairment the OT service delivers holistic intervention to meet the needs identified on both the health and/or the education section of the children's EHCP. This is despite the fact that the 0-25 SEND code of practice states "Therapy services MUST be treated as Special Educational Provision where they educate or train a child or young person".

The NHS Trust Paediatric Occupational Therapy Service (which is solely Health funded) does not provide sensory integration assessments or intervention because this work falls outside the service remit and falls within the remit of special educational provision. However, the Clinical Commissioning Group (CCG) have commissioned a pilot project to evaluate the use of sensory integration (SI) and we have just received the final evaluation report and will be discussing the findings with our colleagues in education about how we commission this going forward. Please be assured that this is a high priority for the CCG.

**Note :** On the 1<sup>st</sup> November 2015 through the Clinical Commissioning Group a newly commissioned OT service for children with Autism Spectrum Disorder was introduced on the island. Further details can be found on the Local Offer [here](#): The working group is looking at further models across the country i.e. Oxford

We also acknowledge the issues you mention around our "Short Breaks" programme. We endeavour to provide for all young people and the variety of programmes has increased over the years. We know that the costs can be quite high and we try where we can to keep these costs down to a minimum. We continually strive to find alternative summer programmes for our children and young people and have been in contact with new providers for next year. You may also be aware of "The Isle of Wight Family Directory" which offers a number of local activities and events for island parents and visiting families. It is updated three times a year - winter, spring and summer. Hard copies are distributed to playgroups, toddler groups, nurseries, Island schools, libraries, local attractions and businesses.
