

Adult Social Care - General Data Protection Regulation (GDPR) Factsheet

What is a GDPR?

In May 2018, the Data Protection Act is being replaced by new legislation. The General Data Protection Regulation (GDPR) is a new piece of EU law that is being introduced to update the existing rules relating to the handling of personal data. Whilst a lot of the provisions are the same as currently, under the Data Protection Act, there are some differences. In particular, it extends the definition of personal data to be wider than currently; it introduces more rights for individuals (data subjects) and there are more responsibilities on data controllers (such as the IW Council) and data processors (third parties who act on our behalf).

Definition of Personal Data

Personal Data can be defined as any information relating to an individual who can be directly or indirectly identified by the data. This definition is extended to include unique reference numbers as well as descriptions of individuals, so care must be taken whenever there is a risk of an individual being identified from the data.

Sensitive Personal Data

The GDPR refers to sensitive personal data as "**special categories of personal data**". It includes data consisting of racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, data concerning health or data concerning a natural person's sex life or sexual orientation. In addition, it includes biometric and genetic data, such as DNA; finger prints, facial recognition, etc.

These types of data are considered more private and require additional security measures to keep them safe and secure.

Collecting Data in Adult Social Care

Whenever we collect personal details, we must explain who we are; what the information is being collected for; who it will be shared with; how long it will be held for; and the rights that individuals have over their data. This forms the basis of what is called a Privacy Notice.

We may also share it with other local authorities or debt collection agents if necessary for the collection of council tax debt. We may share the data with third parties if we are required by law to do so. This may include the Police or Government Agencies.

We will share your data with other relevant teams within the council or other relevant organisations if a child and/or adult safeguarding issue arises and places an individual at risk of harm.

We will keep your personal data for as long as we are required to do so under relevant legislation or in accordance with our operational requirements. You can view our retention schedule on our website https://www.iwight.com/documentlibrary/view/retention-policy-2011.
