#### 1 Introduction

- 1.1 These Terms and Conditions set out the conditions under which the Isle of Wight Council will accept requests for searches of the local authority via the CON29 form and are applicable from 1 April 2024.
- 1.2 The terms and conditions of service may be updated from time to time. The current version of the <u>local land charges terms and conditions</u> is available on the Isle of Wight Council website.

# What are Local Land Charges CON29 searches and to what do they relate?

1.3 The CON29 supplies information relating to public highways, proposals for new roads, rail schemes or planning decisions that could affect the property, as well as outstanding statutory notices, breaches of planning or building regulations or the existence of a compulsory purchase order. Environmental factors, such as whether the house stands on contaminated land or in a Radon gas affected area are also covered.

- 1.4 Additional enquiries can be made via the CON29 (O) optional form which deals with applications on roads proposed by private bodies, completion notices, land maintenance notices and environmental and pollution notices.
- 1.5 The CON29 does not deal with Flood Risk, Public Sewers or Chancel Repairs.

# 2 Overview of the Isle of Wight Council Service/What customers can expect.

- 2.1 The Isle of Wight Council aim to turn CON29 searches around within an average period of ten working days.
- 2.2 Up to six Isle of Wight Council departments may be involved in answering the CON29, and occasionally a search may take longer than an average of ten days due to circumstances beyond the control of the Local Land Charges department.

# 3 Customers Responsibilities

- 3.1 The customer must submit the search through one of the established online portals such as the National Land Information Service (NLIS) or TM Search Choice. They can also be submitted via e-mail to <a href="mailto:llcgeneralenquiries@iow.gov.uk">llcgeneralenquiries@iow.gov.uk</a>
- 3.2 Searches must be accompanied by full payment of the relevant fee, and be accompanied by a map of sufficient scale to clearly identify the boundary of thesearch area which must be shown in red.

# 4 Isle of Wight Council Responsibilities

- 4.1 The Isle of Wight Council will commence processing your search request no laterthan the first working day following receipt, and will, where possible endeavour to return your completed search via the method in which it was submitted with ten working days, subject to the caveat expressed at point 3.2 (above).
- 4.2 The Local Land Charges section is not responsible for the answers provided toany of the questions in the CON29, and further information, clarification or background documents can be obtained from the individual answering departments. #### **Annual Fee Uplift Process**

On 1 April 2025, and on every subsequent 1 April thereafter, all Fees and Charges relating to Local Land Charges (excluding VAT) shall be uplifted by the percentage rate of the Consumer Price Index (CPI) as it stood at the previous September.
