## **3. Declaration of Members' Interest and Chair's correspondence**

- DA . Governor at IW school and also Elected member.  
PH informed members that HK ,Clerk, had informed her and the Chairman that he intended retiring from his role on SACRE. He was thanked for his 16 years of service. The role of Clerk will be brought under the remit of Democratic Services from June 2021

## **6. Membership update**

- Leane Chalmers (CE) and Alex Augustus (LA) were welcomed to their first meeting

## **7. Monitoring Report**

- PH summarised the role of SACRE for the benefit of new members.
- She described the difficulty of SACRE in its monitoring role without GCSE examination results for the 2020 examination series. BH described the outcome of the Teacher Assessment procedure at her school. She thought it had worked well.
- PH Explained that that subject level data was not being collated by the LA, nor DfE for comparison and accountability measures. She explained that the 2020-2021 GCSE exams in England are currently planned to take place 3 weeks later than usual to give some additional teaching time in light of year 10 not being in school (although some were studying online) in summer 2020.
- SACRE requested that PH asks the HIAS officer responsible for IW school improvement to consider asking for entry numbers for GCSE RS in 2020 for SACRE's monitoring purposes.
- Headteacher reps described their approaches to "catch-up" processes in RE. AA explained that the RE in his school was based on the Liturgical Year, so any "catch-up" procedure would be difficult. NM informed members that after 6 months of non-school attendance, her school's priority and emphasis was on the core subjects and pupils' personal development.
- PH informed the meeting that the Secondary networks were continuing. She expressed her appreciation of the hard work and commitment from teachers.
- JB was pleased that the Primary networks were also continuing. Several SENCOs from the IoW had also recently attended a special RE and SEND course. The early December Primary network meeting is fully booked.

## **8. Agreed Syllabus Review of LD111 2020-2021**

- PH was pleased to report that all 4 LA's had agreed to review the Agreed Syllabus.
- A large gathering, on line, had taken place when representatives from those LAs had begun the review procedure. There will be a series of meetings of teacher representatives. Faith leaders have also been consulted. There has been a wide-range of "voices" and quality inputs.
- She explained that the review would include a "spiral" approach to progression, with the aim of increasing children's religious education with both depth and breadth across the Key Stages. The existing purpose statement will remain. There will also be more joined-up thinking across primary and secondary RE.

## 9. Annual Report

- The draft report was presented to the meeting with brief explanations of the various sections.

- South Central Hub. PH explained, for the benefit of new members, the role of this group. Past attenders emphasised the importance and benefits of attending.
- DA will “attend” the meeting on 16.11.2020 10.00-12.00. HK offered to participate if members were unable to attend.
