- 1. An Election is to be held for One Member of Parliament to serve the Isle of Wight West constituency.
- 2. Forms of nomination for the Parliamentary Election may be obtained between the hours of 10 am and 4 pm at County Hall, Newport, Isle of Wight, PO30 1UD from the Acting Returning Officer, who will, at the request of an elector for any electoral area, prepare a nomination paper for signature.
- 3. Nomination papers must be delivered by hand to the Acting Returning Officer, County Hall, Newport, Isle of Wight, PO30 1UD on any day after the date of this notice between the hours of 10 am and 4 pm but no later than 4 pm on Friday, 7th June 2024.
- 4. The £500 deposit may be paid by legal tender, by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom or, with the Acting Returning Officer's consent, by debit or credit card or the electronic transfer of funds.
- 5. If the election is contested the poll will take place on Thursday, 4th July 2024. Where contested, the poll will be combined with the election for members of Parish Councils.
- Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Tuesday 18th June 2024. Applications can be made online: <u>https://www.gov.uk/register-to-vote</u>.
- Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Wednesday 26th June 2024. Applications can be made online: <u>https://www.gov.uk/apply-for-photo-id-voter-authority-certificate</u>
- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at County Hall, Newport, Isle of Wight, PO30 1UD by 5 pm on Wednesday 19th June 2024
- 9. New applications to vote by proxy at this election must reach the Electoral Registration Officer at County Hall, Newport, Isle of Wight, PO30 1UD by 5 pm on Wednesday 26th June 2024.
- 10. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at County Hall, Newport, Isle of Wight, PO30 1UD by 5 pm on Thursday, 4th July 2024. The physical incapacity must have occurred after 5 pm on Wednesday 26th June 2024. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday 26th June 2024.
