Alteration description

2. A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

The proposal is to introduce a new resourced provision at the The Bay CE School (Primary site) for 12 children with Autism Spectrum Condition (ASC).

School capacity

- **3.**—(1) Where the alteration is an alteration falling within any of paragraphs 1 to 4, 8, 9 and 12-14 of Schedule 2 (GB proposals)/paragraphs 1-4, 7, 8, 18, 19 and 21 of Schedule 4 (LA proposals) to The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2007 (as amended), the proposals must also include

The Bay CE School is a 4-16 school with the Primary and Secondary schools located on separate sites. The primary school capacity is 420 places. The proposal introduces a resourced provision on the primary site for 12 children. The age range for admission to the provision will be 4-11.

(b) details of the current number of pupils admitted to the school in each relevant age group, and where this number is to change, the proposed number of pupils to be not admitted in each relevant age group in the first school year in which the proposals will have been implemented;

The Bay CE School has a PAN of 60 for Primary. The proposed arrangement would allow for 12 pupils at the primary site.

Objectives

6. The objectives of the proposals.

The proposal is to introduce a new resourced provision at the Primary site for 12 pupils with ASC.

Consultation

- 7. Evidence of the consultation before the proposals were published including—
 - (a) a list of persons who were consulted;
 - (b) minutes of all public consultation meetings;
 - (c) the views of the persons consulted;
 - (d) a statement to the effect that all applicable statutory requirements in relation to the proposals to consult were complied with; and

The Isle of Wight Council (IWC) has a statutory duty to provide sufficient specialist educational places for children and young people with Special Educational Needs Disability (SEND) on the Isle of Wight.

The current Strategic Review of Specialist Places for children and young people with an Education, Health and Care Plan (EHCP) showed that further specialist provision for SEMH (Social, Emotional and Mental Health), ASC (Autism Spectrum Condition), SLCN (Speech, Language and Communication Needs) and MLD (Moderate Learning Difficulties) was needed both at primary and secondary education.

In June 2020 the outcomes of this review were completed and can be viewed here (PDF, 1.89 MB, 34 pages).

The proposed additional SEND provision at The Bay CE School will help manage some of the school place pressures generated by the increase in the number of Education Health and Care Plans (EHCPs) maintained by the local authority and allow placement of additional children for September 2025.

Requirements for local authorities to put in place an accessibility strategy are specified in schedule 10 of the Equality Act: Accessibility for disabled pupils. This schedule provides for accessibility arrangements for pupils in schools as set out in section 88.

Project costs

£30,000 is needed for the Primary site to remodel existing classroom spaces to ensure appropriate accommodation is provided.

The local authority will make these funds available through the High Needs Budget.

Extended services

The proposals do not affect the provision of the school's extended services.

Need or demand for additional places

Isle of Wight Council has a statutory duty to provide school places for all children including those who have special educational needs and or a disability.

These additional places are required following the conclusion of the comprehensive review of the need for specialist educational places on the island and the publication of "the Isle of Wight Council's strategy for a continuum of Special Educational Needs and/or Disabilities (SEND) provision for children and young people from 0 to 25 years." in June 2020.

That report identified trends in current SEND populations on the Isle of Wight and projected trends in demographics which may impact on future SEND provision. It identified where additional provision was required and made recommendations for its development to meet needs on the Isle of Wight.

It concluded that there was an increase in children with ASC needs on the Island, some of whom will require specialist places. This resourced provision will provide 12 spaces at the primary site.

The proposed resourced provision provides additional places for pupils in the local area with an appropriate EHCP and will be commissioned and placed by the Local Authority – places will be agreed with the school and no preference/priority will be made in regard to religion.
