



## Isle of Wight Council Tennyson Trail Traffic Regulation Order Permit Scheme

**Please read the following notes carefully and complete the attached application.**

The Tennyson Trail is a Byway Open to All Traffic which is an unsurfaced track maintained to the standard of a bridleway and has some steep gradients and uneven surfaces. It is your responsibility to ensure that you have a suitable vehicle for use on the Trail.

The Traffic Regulation Order (TRO) applying to the Trail between Nodgham Lane, Carisbrooke and the Military Road, Freshwater Bay prohibits access by all public motor vehicle traffic.

Persons in one of the following categories may apply for a permit to allow them to take a nominated vehicle along the Trail during the period 1 April until 30 September inclusive. Permit holders are required to sign an undertaking that they will drive with due care and attention and will not at any time exceed 10mph.

- Holders of a current Blue Badge for disabled people with mobility problems
- Taxis (licensed hackney carriages)
- Community vehicles

The Permit Scheme is for the purpose of assisting those persons who would not otherwise be able to enjoy the Trail due to limited mobility. Permits will be restricted to community vehicles used for this purpose.

In the case of Blue Badge holders, the applicant (badge holder) must be present in the vehicle when using the Trail. The permit is not transferable to any other person.

In the case of community vehicles, the applicant should be the keeper of the vehicle and the names of regular drivers be given.

**Please note:**

- **Normal motoring legislation applies.**
- **The vehicle must be roadworthy.**
- **It is an offence to drive a motor vehicle on a Byway without valid MOT, insurance and driving licence.**
- **Keep to the Byway - it is an offence to drive a motor vehicle on a public footpath or bridleway.**
- **Expect to encounter others – pedestrians, horse riders, cyclists, farm operations.**
- **Expect to encounter uneven and difficult surfaces.**
- **Exercise a high level of due care and attention.**

**The personal information we collect and use**

In the course of processing your application, we collect the personal information including your full name, contact details and details of your vehicle(s)/permit(s).

**How we use your personal information**

We use your personal information to process an application pursuant to The Isle of Wight Council (Tennyson Trail, IW) (Prohibition of Driving) Order No 1 2006 made in accordance with the Road Traffic Regulation Act 1984.

**How long your personal data will be kept**

We will hold your personal data for as long as we are required to do so under relevant legislation or in accordance with our operational requirements. You can view our retention schedule on our website [www.iwight.com](http://www.iwight.com).

**Reasons we can collect and use your personal information**

The lawful basis on which we collect and use your personal data is that ‘processing is necessary for compliance with a legal obligation’.

The provision of personal contact data is required from you to enable us to process the said application and if successful to retain it as a record of a permit being issued.

**Who we share your personal information with**

The information in this application form may be shared with other Council departments and the Police for the purposes of verifying that you are able to drive on the Byway in accordance with any permit issued.

**Section 3 continued:**

We will share **all** personal data with third parties if we are required by law to do so. This may include the Police and other law enforcement authorities/agencies.

The permitted vehicle will be roadworthy and have a valid MOT. The driver will hold a valid driving licence and be adequately insured in accordance with usual motoring legislation.

I understand that the Isle of Wight Council reserves the right to withdraw a permit and/or refuse the issue of a future permit if I fail to observe these undertakings or any other rules and regulations relating to the TRO and Permit Scheme.
