# **Job Purpose**

Under the guidance of senior staff – provide general administrative / financial support to the school.

# **Major Tasks**

- 1. Promote equality as an integral part of a role and treat everyone with fairness and dignity.
- 2. To develop and maintain a generic skill set that allows the Isle of Wight Council to employ your skills, abilities and experience across the Council and its formal partnerships as needed.

### Organisation:

- 3. Undertake reception duties, answering general telephone and face-to-face enquiries and signing in visitors.
- 4. Assist with pupil first aid / welfare duties, looking after sick pupils, liaising with parents / staff etc.
- 5. Assist in arrangements for school trips, events, etc.

#### Administration:

- 6. Provide general clerical / admin support e.g. photocopying, filing, faxing, complete standard forms, respond to routine correspondence.
- 7. Maintain manual and computerised records / management information systems.
- 8. Produce lists / information / data as required e.g. pupils' data.
- 9. Undertake typing and word processing and other IT based tasks.
- 10. Take notes at meetings.

- 11. Sort and distribute mail.
- 12. Undertake administrative procedures.
- 13. Maintain and collate pupil reports.
- 14. Undertake routine administration of school lettings and other uses of school premises.

#### Resources:

- 15. Operate relevant equipment / complex ICT packages (e.g. Word, Excel, databases, Internet).
- 16. Maintain stock and supplies, cataloguing and distributing as required.
- 17. Operate uniform / snack / other 'shops' within the school.
- 18. Provide advice and guidance to staff, pupils and others.
- 19. Undertake general financial administration e.g. processing orders.

#### Responsibilities:

- 20. Be aware of and comply with policies and procedures relating to child protection, health, safety and security, confidentiality and data protection, reporting all concerns to an appropriate person.
- 21. Be aware of and support difference and ensure equal opportunities for all.
- 22. Contribute to the overall ethos / work / aims of the school.
- 23. Appreciate and support the role of other professionals.
- 24. Attend and participate in relevant meetings as required.
- 25. Participate in training and other learning activities and performance development as required.
