Job Purpose

To lead shifts of support workers to ensure children have an outstanding experience either living at or accessing a short break stays at Beaulieu House. To promote a nurturing, safe and positive environment for children to live or have a short stay in.

- 4. To lead in an emergency to ensure the child's welfare and safety are prioritised, acting as a first aider and fire marshal for the shift.
- 5. To support children who have behaviours that challenge using PROACT SCIPr and restorative approaches identified in the child's plan of care including the use of physical intervention.
- 6. Follow plans of support, such as care plans, risk assessments and behaviour support plans and to work within the legislation 1989 Children's Act and Children's Homes regulation's 2015.
- 7. To supervise support workers monthly ensuring a high quality of care to children receiving services at Beaulieu house.
- 8. To work in partnership with parents as link workers to the child under the supervision of the deputy manager. Attend and contribute planning meetings and statutory reviews as a link worker as and when required.
